### Adam Segal

Ira A. Lipman Chair in Emerging Technologies and National Security, Director of the Digital and Cyberspace Policy Program, Council on Foreign Relations

**Dr. Adam Segal** is the Ira A. Lipman chair in emerging technologies and national security and director of the Digital and Cyberspace Policy program at the Council on Foreign Relations (CFR). An expert on security issues, technology development, and Chinese domestic and foreign policy, Segal was the project director for the CFR-sponsored Independent Task Force Reports *Innovation and National Security: Keeping Our Edge* and *Defending an Open, Global, Secure, and Resilient Internet*. His book *The Hacked World Order: How Nations Fight, Trade, Maneuver, and Manipulate in the Digital Age* (Public Affairs, 2016) describes the increasingly contentious geopolitics of cyberspace. His work has appeared in the *Financial Times*, the *New York Times, Foreign Policy*, the *Wall Street Journal*, and *Foreign Affairs*, among others. He currently writes for the blog, "Net Politics."
