

## Speaker's biography



**Ji-Young Lee** is an Associate Professor of International Relations at American University's School of International Service, where she holds the C. W. Lim and Korea Foundation Professorship of Korean Studies. Trained as a political scientist, she has written on Asian historical international relations, regional security order and the US alliance network in East Asia, and South Korean foreign policy. She is the author of *China's Hegemony: Four Hundred Years of East Asian Domination* (Columbia University Press, 2016). She has published articles in journals, including *Security Studies*, *International Relations of the Asia-Pacific*, *the Pacific Review*, *the Australian Journal of International Affairs*, and the *Journal of East Asian Studies*. She previously taught at Oberlin College as a Mellon Postdoctoral Fellow in Politics and East Asian Studies. Outside academia, she served as the inaugural Korea Policy Chair and a Senior Political Scientist at the RAND Corporation



**Naosuke Mukoyama** is an Associate Professor of Global Governance at the Institute for Future Initiatives, University of Tokyo. His research examines the emergence and development of the sovereign state, covering state formation, resource politics, and historical international relations. He is the author of *Fueling Sovereignty: Colonial Oil and the Creation of Unlikely States* (Cambridge University Press, 2024). His work has appeared in *European Journal of International Relations*, *Comparative Politics*, and *Democratization*, among others. Before joining UTokyo, he was a Postdoctoral Fellow at the Department of Politics and International Studies at the University of Cambridge. He received his DPhil (Ph.D.) from the University of Oxford, and his MPhil and LLB from the University of Tokyo.



**Antoine Roth** is Assistant Professor at the Graduate School of Law of Tohoku University in Sendai. His research and teachings focus on China's foreign relations, on the international politics of East Asia and on the evolution of international order in the region. He holds a Master in Asian Studies from the George Washington University and a PhD in international politics from the University of Tokyo. He is the author of *A Hierarchical Vision of Order: Understanding Chinese Foreign Policy in*

*Asia* (Bristol University Press, 2023).



**Ryo Sahashi** is a Professor of International Relations, Institute for Advanced Studies on Asia, the University of Tokyo. Dr. Sahashi specializes on international politics in East Asia. He sits on government panels including the Council on the Use of Real Estate and the Advisory Board for Promoting Science and Technology Diplomacy. He also works as Visiting Fellow of Keidanren Policy Research Institute. He has been visiting scholars with Stanford University, the Wilson Center, and Seoul National University. He sits on the board of Japan Center for International Exchange and National Bureau of Asian Research.

Dr. Sahashi received his Ph.D. from the Graduate Schools for Law and Politics at the University of Tokyo. His recent books are *US-China Rivalry: A Shift of American Strategy and Divided Worlds* (Chuko, 2021) and *In a Search for Coexistence: the United States and Two Chinas during the Cold War* (Keiso, 2015), and he edits *America Under Trump: Divided at Home, Watched by the World* (The University of Tokyo Press, 2025), and *Asia Rising: A Handbook of History and International Relations in East, South and Southeast Asia* (Springer, 2024). He has been on the editorial board on *Asia Policy*, *Japan Studies* (HUFS), and *International Journal of Asian Studies*.
